**ORDER GRANTING
PLAINTIFFS' MOTION FOR
CLASS CERTIFICATION**

On August 12, 2022, Plaintiffs moved the Court for an order certifying a class, appointing the named plaintiffs as Class Representatives, and appointing Richard M. Paul III of Paul LLP, Jason Hartley of Hartley LLP, and Joseph Saveri of The Saveri Law Firm, LLP as Class Counsel along with Bruce Greenberg as Liaison Counsel, pursuant to Rule 23 of the Federal Rules of Civil Procedure.

This matter having been opened to the Court by Lite DePalma Greenberg & Afanador, LLC, on notice to all counsel, and the Court having considered the papers submitted by the parties, and having heard oral argument on _____, 2022, and good cause appearing, finds that certification of this action to proceed as a class action under Rules 23(a) and (b)(3) is warranted.

The following Class is hereby certified:

All persons who worked in a tax preparer position at any company-owned Jackson Hewitt location in the United States at any time between December 10, 2014 and the present.

Excluded from the Class are Defendants and their affiliates, the Judge, including the Judge's staff and immediate family members, senior executives, personnel in Jackson Hewitt executive, HR and recruiting departments, persons outside of the United States, franchisee owners, and managers.

Pursuant to Rule 23(g), the Court finds proposed Class Counsel and Liaison Counsel will continue to adequately represent the Class and hereby appoints Richard M. Paul III of Paul LLP, Jason Hartley of Hartley LLP, and Joseph Saveri of The Saveri Law Firm, LLP as Class Counsel along with Bruce Greenberg as Liaison Counsel.

The Court further finds the named Plaintiffs are adequate and appoints Jessica Robinson, Priscilla McGowan, and Stacey Jennings as Class Representatives.
